\*Big boats (over 40 feet) will be subject to a special handling surcharge of **\$275.00**.

\*\*Environmental fee of **\$2.00** per foot will be assessed for Bottom Paint and Power Wash services.

**Estimate Policy** - Schooner Creek Boat Works gladly provides fixed-rate job estimates free of charge.

When the work involves investigating and discovery time on mechanical, electrical, structural, or plumbing systems, an hourly fee is charged at **\$115.00/hr** (30 minute minimum). If Schooner Creek does work related to the estimate, the charge will be credited to the final bill.

**All hourly prices are per person per hour.**



# Rules of Operation

Please help us maintain a green boat yard

- All visitors must sign a waiver of liability to enter our facility.
- Work on vessels by customers in any lot is not allowed. We are not a do-it-yourself boatyard. Repairs can only be completed by Schooner Creek Boat Works at the current labor rate.
- Due to OSHA regulations, customers are not allowed in any working areas of the shop during business hours.
- For safety reasons, please no cranking of any combustible engines on the hard.
- Discharge of marine sanitary device is strictly prohibited.
- Please do not disturb tarps placed under vessels; they help us contain hazardous materials.
- Our permit prohibits any washing of vessels while cradled in the yard. Washing must be done in the appropriate area by Schooner Creek Boat Works employees.
- Do not, under any circumstances, move boat stands; we would be happy to assist, just ask.
- Please leave your vehicles outside the gate. If left in the way of Travelift, they will be towed.
- The service office staff is available for consultation; please do not disturb the employees working on vessels.
- Radios, boom boxes, DVD players, etc. are not allowed. Thank you for your consideration.
- No drugs or alcohol in yard.
- Please, no pets of any kind are allowed in boat yard. The chemicals associated with boat repairs are not good for them.
- No fishing or cleaning of fish.
- Please dispose of any toxic materials according to EPA regulation. The Schooner Creek Boat Works dumpster is not an approved disposal facility. It is to be used for normal garbage only; the boat owner should haul large amounts of waste off the premises.
- Permit regulations prevent us from allowing you to stay aboard your boat when it is at Schooner Creek Boat Works for repairs.
- Schooner Creek Boat Works reserves the right to launch any vessels with standing rigs in case of forecast high winds.
- Schooner Creek Boat Works charges \$35.00 hour/per person for outside contractors. Proof of liability insurance is required. Outside contractors must sign in at the office and sign out at the end of the day. You will be charged 8 hours for any day you do not sign out.
- Employees of customers will be treated as outside contractors.
- Schooner Creek Boat Works reserves the right to inspect all vessels in long term and short term storage, including the interior of your vessel.
- Proof of liability insurance is required for any vessel in storage.
- Storage at our facility requires completion of a storage agreement and having a credit card on file. Storage fees are automatically billed at the beginning of the month.
- Please follow your gut feeling; if what you are doing feels like it may have a negative effect on the environment, don't do it.
